- I give permission for my child to participate in Student Ministry activities organized by and/or participated in with Brighton Church of the Nazarene.
- I agree that, once registered for an activity, I am responsible for my child's participation and full payment.
- I understand that my child and other participants in these activities will be transported to and from said activities either via church owned vehicle, private vehicle, rented vehicle (i.e., car, van, charter bus), or airplane, and I hereby authorize him/her to travel in whichever form of transportation is used. I further acknowledge the right and necessity of said vehicle(s) to make incidental stops en route to and in return from the designated activity when determined to be necessary or desirable by church staff or adult sponsors of Brighton Church of the Nazarene.
- I understand that my child and other participants in these activities have agreed to certain rules governing these activities. I understand that the failure to abide by these rules by my child may result in the search of his/her personal belongings and may also result in my child being sent home, and I agree to be responsible to pick up my child if such a violation occurs, at my expense.
- I hereby release Brighton Church of the Nazarene, its staff and its adult sponsors from responsibility and liability for any injury or illness that my child may sustain during these activities. In the event that my child is injured during these activities and requires the attention of a doctor, I consent to any reasonable medical attention of a doctor and any reasonable medical treatment as deemed necessary by the licensed physician. In the event treatment is called for which the medical staff or hospital refuse to administer without my consent, I hereby authorize any church staff or adult sponsor to act as my agent to consent to any x-ray examination; medical, dental or surgical diagnosis; treatment; and hospital care advised and supervised by the licensed physician, as appropriate, licensed to practice under the laws of the state where the services are rendered, either in a doctor's office, clinic or in any hospital.
- In the event that medical attention is needed for my child while participating in Student Ministry activities, I agree that I will be ultimately responsible for the cost of such medical care to the extent not covered by my child's health insurance provider.
- Should any injury occur to my child during or as a result of any Student Ministry activity, I agree to release and hold harmless the church staff and adult sponsors of Brighton Church of the Nazarene from any and all claims, suits, costs, and actions, of any kind whatsoever, arising from their exercise of the power granted by this authorization. If a dispute over this agreement or any claim for damage arises, I agree to resolve the matter through a mutually acceptable arbitration process.

BRIGHTON CHURCH OF THE NAZARENE PARTICIPANT COVENANT PROMISE

I PROMISE TO FOLLOW THE LIST BELOW...

1. No drugs, alcohol, weapons of any sort (including pocket knives), or fireworks (including sparklers, party poppers and snap pops).
2. No sexual activity of any kind.
3. No PDA (public displays of affection, hand holding, hugging, kissing).
4. No guys in girls' rooms and no girls in guys' rooms.
5. Respect others and their property.
6. Be in rooms by curfew & no sneaking out after curfew, when curfew applies.
7. Stay in groups of **no less** than 3.
8. Check in with chaperones at designated times throughout the activity.
9. No gambling of any kind.
10. When swimming and involved in any water-related activities, guys must wear shorts style trunks (no speedos) and girls must wear one-piece bathing suits. (Tankinis are acceptable as long as they show no midriffs and top is not low cut.)
11. Cell phone rules will be announced by Student Ministry leaders at the time of registration dependent upon the activity.

Remember that when you are at an activity with the Brighton Church of the Nazarene, you are representing the church and you are representing God. You should do so in a way that would be honorable and glorifying to HIM.

Any rule broken will result in a phone call home made by the student in which the student will explain the situation to their parent(s)/guardian(s). Breaking rules could result in IMMEDIATE dismissal from the activity. The student will be sent home at his or her own expense. If sent home from any activity, the student will forfeit their opportunity to attend any future activities prior to meeting with the Student Ministry leaders.

By signing below, you affirm that you have read and understand all of these promises. You agree to abide by these promises while representing the Brighton Church of the Nazarene in any capacity. You also agree to accept any consequence that will be enforced as a result of violation of these promises.
